phase of competition; however, each pageant system has different formats for when their interviews are conducted and what platform or type of interview they will conduct.

## **The Panel Interview**





## **ROUND ROBBIN**

During a Round Robbin interview style, the contestant will be in a room with other contestants, the contestant will interview with each judge. Someone will direct the contestant on when to go and where to stand.

During a panel interview, the contestant will speak to a group of judges in a room, usually with no other contestants present.

## **Practice Makes Perfect**

## **GENERAL INTERVIEW RULES**

Help contestants score big by knowing what to expect!


### Judges will assess:

- 1. The content ane depth of knowledge in the contestant's answers.
- 2. The contestant's body language.
- 3. The contestant's confidence in what they say.
- 4. The consistency in what they say and the contestant's brand.
- 5. The contestant's preparedness and ability to carry out the job of the titleholder.



## HOW TO STAND OUT!

- 1. Know and embrace your brand. This will help you be clear on who you are.
- 2. Teach your client to always be aware of their body language and what message it is sending.
- 3. Make sure your client is informed and is abreast of current events.
- 4. Know your paperwork.
- 5. Have contestant be intentional about their eye contact by connecting with each judge.
- 6. Contestant must have a clear plan on how they will impact the community with their platform if chosen the winner.



# WHAT TO WEAR?

With a room full of beauty and poise, it's crucial that your client's interview ensemble has to get attention as soon as she walks in the room.

Be sure your client's outfits are in line with the brand of the pageant.

Be sure the outfit is flattering in fit, style, and color.



# WHAT TO COLOR TO WEAR?

Don't be afraid to advise your client to go with something bold, yet complimentary to their skin tone and still on the pageant brand.

#### **Pastels and Prints**

They can work but they should not be too busy or distracting with a simple design.

## INTERVIEW ACCESSORIES

Your contestant's accessories will depend on their outfit, but there are some general rules about accessories.

With a bling outfit - keep the accessories simple.

With a simpler outfit - You can make jewelry a little more pronounced but make only one piece the focal point.

**Shoes** - Keep them simple and stylish. Make sure they are age appropriate and not too high.

**Earring Only** - It is standard to only wear earrings in pageant competition as bracelets, necklaces, and anklets are considered distracting.



## INTERVIEW ACCESSORIES

- 1. Contestants must have a clearly defined contestant brand and strategy on how they will articulate it.
- 2. Contestants need to be well-versed on their platform and develop talking points to discuss the impact they've made.
- 3. Contestants should practice with a variety of questions ranging from their life experiences, knowledge of current events, knowledge of the pageant system, their platform and hypothetical scenarios.
- 4. Contestants need to develop a strong command of both verbal and nonverbal communication.
- 5. Contestants must develop their confidence.






